

## **CONTRACTUAL CONDITIONS OF INSPECTION ACTIVITIES**

**1. TERMS AND CONDITION FORM IS SOLELY OWNED AND OPERATED BY TECHNICAL SAFETY CONSULTANTS [TSC] . PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY & MUST AGREE TO BE BOUND BY THESE TERMS AND CONDITIONS.**

- Inspection Report / Certificate will be issued after receipt of 100 % Payment Service Order.
- The client shall provide the reasonable and continuous access to the test locations with a well-defined exclusion zone and provide adequate light if required.
- The client is responsible for ensuring that designated, competent personnel are available at site to drive or maneuver the inspection object.
- The client shall also take care of the necessary cleaning and preparation of the test object and its associated equipment and instruments.
- Detailed work instruction and permit to work to be given to TSC personnel by client's Technical/Safety Department.
- In case of rejection in inspection or unsafe condition of equipment, the client will be liable to pay full amount of job.
- Visiting/Cancellation Charges will be applicable same as per the quotation amount.
- If the job is outside UAE, all expenses including air ticket, accommodation, courier charge and food etc., shall be provided by the client.
- Any delay during inspection due to unforeseen circumstances at site, client will be liable to pay additional charges for the delay.
- In any event of standby during the day rate work, the teams and equipment shall be charged at 100% of the standard day rate.
- Normal Working Hours means an eight hour work period between the approximate hours of 8.00AM to 5.00PM from Saturday to Thursday. For any additional working hours beyond the standard working hours & working hours (including travelling) on Fridays and public holidays, additional charges will apply.

**2. Memorandum**

- The Inspection report / certificate issued by TSC is a record of the inspection conducted on products and the results thereof unless otherwise specified in the report, the results are applicable to only to those products, which have been inspected and do not apply to other product even though declared to be identical.
- The report / certificate, if reproduced for any purpose commercial or otherwise should be reproduced in full. Reproduction of a part of the report or an abstract thereof must be specifically approved from TSC.

**3. Liability & Confidentiality Clause**

- Under no circumstances, Technical Safety Consultants accepts any responsibility / liability for the loss or damage, consequential or otherwise caused to the equipment or property while being tested.
- TSC shall not be liable for any change in product or its performance of inspected item, due to any damage caused to it after the Inspection report / certificate, in respect of it, has been issued.
- This Documents shall be consider confidential between TSC & party receiving, it shall not disclosed to any third party without prior approval of TSC.
- All the information obtained and created during the performance of inspection activity shall be kept confidential. Prior approval shall be obtained from the client before the release of any information on public domain.
